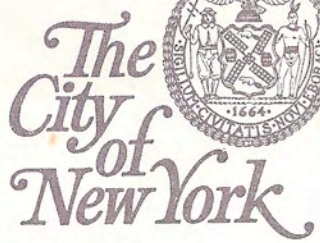

## Help for the F.B.I.

"F.B.I. Confirms Amazing Powers of Psychic," said the headline on this week's front page of The National Enquirer.

According to the tabloid's account, the psychic, Noreen Renier of Orlando, Fla., has lectured at the Federal Bureau of Investigation Academy in Quantico, Va., and "stunned an audience of officers there in January of 1981" when she predicted the attempt to assassinate President Reagan that occurred two months later.

The article said the bureau had since referred Ms. Renier to local police departments looking for otherworldly help in investigations.

Is the article true? An F.B.I. spokesman had no comment yesterday.
